FINAL VERSION OF THE CONCESSION AGREEMENT FOR THE MEGAPROJECT OF HEADWORKS AND CONVEYANCE FOR THE SUPPLY OF DRINKING WATER TO LIMA PUBLISHED

The draft final version of the concession agreement for the Megaproject of Headworks and Conveyance for the Supply of Drinking Water to Lima was published. This strategic initiative aims to guarantee a sustainable water supply for more than 7.5 million inhabitants of the capital city. The project includes the construction of the Trans-Andean Conveyance Tunnel (approximately 10 km), the expansion of the Huachipa Drinking Water Treatment Plant, and the implementation of additional infrastructure for water intake, regulation, and transport, strengthening Lima's water resilience in the face of urban growth and climate change.

THIRD VERSION OF THE CONCESSION AGREEMENT FOR THE PROJECT "IMPROVEMENT OF PUBLIC TOURISM SERVICES AT THE CHOQUEQUIRAO ARCHAEOLOGICAL PARK" PUBLISHED

The Third Version of the Concession Agreement for the Project "Improvement of Public Tourism Services at the Choquequirao Archaeological Park" has been published. Bidders may submit comments and suggestions until February 11, 2026.

ANCÓN INDUSTRIAL PARK PROJECT AWARDED

On December 12, 2025, PROINVERSIÓN announced the award and commencement of execution of the Ancón Industrial Park, a strategic project for North Lima requiring an investment exceeding USD 1.2 billion. Conceived as the country's first "dry port," the project will cover more than 1,300 hectares, connect with Jorge Chávez International Airport and the ports of Chancay and Callao, and boost logistics and industrial activity. The project was awarded to the Junefield Ancón Industrial Park Consortium.

PUERTO MALDONADO WASTEWATER TREATMENT PLANT (WWTP) PROJECT AWARDED

The Puerto Maldonado Wastewater Treatment Plant (WWTP) project was awarded to the Puerto Maldonado Sanitation Consortium, composed of BTD Capital 12, S.L. and MOTA-ENGIL CAPITAL, S.A., together with MOTA-ENGIL PERÚ S.A.

The project, which will require an investment of over USD 150 million, will be executed under a 24-year concession scheme and includes the design, financing, construction, operation, and maintenance of the system, as well as the installation and rehabilitation of sewer networks and household connections. It will contribute to the environmental recovery of the Tambopata and Madre de Dios rivers and to improved public health in the city.

ADDENDUM NO. 5 TO THE MATARANI PORT TERMINAL CONCESSION AGREEMENT SIGNED

The Peruvian State executed Addendum No. 5 to the Matarani Port Terminal concession agreement, committing approximately USD 700 million in private investment to modernize and expand the port's operational capacity, consolidating it as a key logistics hub for southern Peru.

The agreement extends the concession for an additional 30 years, ensuring long-term operational continuity. It is expected to increase berth capacity by 25%, cargo handling by 50%, and significantly

expand mineral storage capacity, strengthening the port's role as a logistics platform for mining, agro-exports, fishing, and foreign trade. To access the Addendum No. 5 project, click [HERE](#).

ADDENDUM NO. 11 TO THE CONCESSION AGREEMENT OF THE FIRST GROUP OF PERUVIAN AIRPORTS SIGNED

The Government executed Addendum No. 11 to the concession agreement of the first group of regional airports operated by Aeropuertos del Perú (AdP). This addendum enables the modernization of twelve regional airports, including terminals in border zones and areas of high demand. Planned improvements include new boarding lounges, runways, parking areas, and upgraded airport services, accelerating investments to enhance regional airport infrastructure. CHIMBOTE SPECIALIZED HOSPITAL PROJECT ENTERS FINAL TECHNICAL FILE STAGE

On November 24, 2025, official authorization was granted for the building height approval for the future Chimbote Specialized Hospital, part of EsSalud's Áncash Healthcare Network. This authorization is a mandatory regulatory requirement to ensure the viability of the architectural design and to move forward with completion of the project's technical file.

With this approval, the project enters the final validation stage prior to construction. The hospital will expand high-complexity healthcare services in Áncash and will include 161 hospital beds, 12 ICU beds, 7 operating rooms, 37 outpatient clinics, 2 delivery rooms, a progressively complex outpatient clinic, and temporary contingency infrastructure to ensure continuity of service during construction.

NEW INVESTMENT CEILING EXCEEDING PEN 66 BILLION FOR WORKS FOR TAXES (Oxi) FOR REGIONAL AND LOCAL GOVERNMENTS IN 2026

The Executive Branch formalized a significant increase in the maximum CIPRL ceilings, raising by 50% the annual capacity of regional and local governments to commit resources through the Works for Taxes (Oxi) mechanism. With this change, the consolidated ceiling rises to PEN 66.839 billion, substantially expanding the financial capacity of subnational entities to promote public investment projects in priority sectors such as health, education, transportation, sanitation, and public safety.

By Supreme Decree No. 252-2025-EF, the annual capacity of regional governments increases from PEN 21.722 billion to PEN 32.589 billion, and that of local governments from PEN 22.768 billion to PEN 34.250 billion. The largest increases are observed in regions such as Áncash, whose ceiling rises from PEN 317 million to PEN 1.841 billion (an increase of 481%), followed by Ica (234%), Piura (189%), and Huancavelica (145%). PROINVERSIÓN TO PROMOTE THE EXECUTION OF 15 KEY ADDENDA TO STRENGTHEN PPP PROJECT IMPLEMENTATION

PROINVERSIÓN plans to execute and manage 15 priority addenda in Public-Private Partnership projects, representing approximately USD 15.8 billion in additional investment commitments.

Among the prioritized addenda are the expansion of Torre Trecca and contractual adjustments in the Salog and Cálidda projects. Progress is also expected on addenda for the Second Group of Airports, Lima Metro Line 1, Road Network No. 6, the Callao Transporter, and contractual modifications to the Natural Gas Pipeline Transportation System, all aimed at improving operational capacity and accelerating large-scale investments.

Two of these addenda are scheduled for the first quarter of 2026: the Salog (EsSalud) addendum, aimed at optimizing logistics and support services with an estimated commitment of USD 133 million, and the Cálidda (MINEM) addendum, which will adapt natural gas distribution infrastructure with a projected investment of USD 643 million.

The ODCC Project is a self-financed state initiative currently in the transaction phase, aimed at expanding the availability of potable water in Metropolitan Lima. Its first phase involves an estimated investment of USD 480 million and will benefit 1.5 million residents in districts such as Pachacámac (Manchay), Cieneguilla, Ate, Santa Anita, and La Molina. This phase includes the design, financing, construction, operation, and maintenance of the Huachipa II Treatment Plant (2 stages of 2.5 m³/s), the Southern Branch up to Manchay with 5 reservoirs, as well as the operation of the Huachipa Intake and Huachipa I Plant. The final version of the contract is scheduled to be published on December 15, 2025.

WASTEWATER TREATMENT FOR FINAL DISPOSAL OR REUSE FOR THE CITY OF CAJAMARCA

It includes the design, financing, construction, operation, and maintenance of a wastewater treatment plant with an average capacity of 592 L/s, as well as 18 km of collector sewers and a 1.5 km outfall to the Cajamarquino River. The project will benefit the city of Cajamarca and three localities in the Baños del Inca District (Tartar Grande, Bajo Otuzco, and Cerrillo), improving public health, environmental conditions, and quality of life for more than 365,000 people. With a 26-year concession term, it constitutes a high-impact, sustainable investment.

IMPROVEMENT OF PUBLIC TOURISM SERVICES AT THE CHOQUEQUIRAO ARCHAEOLOGICAL PARK

The main objective of the project is to improve the provision of public tourism services at the Choquequirao Archaeological Monument (MACH) through the implementation of a cable transportation system that facilitates access to the site and enhances the visitor experience. This initiative seeks to overcome the current access limitations that restrict visits to the archaeological park, representing a missed opportunity to leverage a valuable tourism asset that could strengthen and consolidate the tourism offering at both the regional and national levels.

The project contemplates the construction of a cable car (aerial tramway) system, consisting of two sections in the Northern Zone and one section in the Southern Zone, in order to improve tourist access to the Choquequirao Archaeological Monument.

The third version of the Concession Agreement has already been published, and bidders have until February 11, 2026, to submit their comments.
